### GROWTH OF PATTAMKATTIMARAVAR TRUST (21-22, 22-23, 23-24 & 24-25)

Over the past four years, the Pattamkattimaravar Trust has demonstrated substantial growth and resilience. Our success reflects a deep commitment to our mission and a dedication to effective resource management

**Financial Year - 2021-22:** In our early stages, the trust had a modest income of ₹31,219, primarily from donations and membership fees. Despite a small deficit of ₹388 after covering our expenditures, this year was crucial in helping us understand the financial demands and establish a foundation for future growth.

**Financial Year - 2022-23:** Building on the previous years' experience, the trust experienced significant growth, with income increasing to ₹51,010. This rise was largely due to an increase in donations and membership fees. Our activities expanded, and despite higher administrative costs, we ended the year with a surplus of ₹2,301. This marked a positive turnaround and demonstrated our growing impact and financial stability.

**Financial Year - 2023-24:** The trust's growth trajectory continued, with income reaching ₹84,018. This increase enabled us to expand our support to more initiatives while maintaining control over administrative expenses. The result was a healthy surplus of ₹8,222, underscoring our ability to manage growth effectively and sustain our mission.

Financial Year - 2024-25: This year saw a consolidation of our efforts, with income from donations and membership fees at ₹71,086. A strategic shift in our administrative and accounting expenses, which increased to ₹21,170, allowed us to restructure our operations. After accounting for all expenditures, the trust concluded the year with a deficit of ₹985, a testament to our continued commitment to our mission even during periods of operational adjustment.

**Overall Growth:** From 2021 to 2025, Pattamkattimaravar Trust has evolved from a fledgling organization to a well-established entity. Our financial management has enabled us to significantly expand our impact, supporting a range of initiatives and establishing a foundation for sustainable growth. We remain committed to continuing this trajectory, leveraging our resources, and further expanding our reach to fulfil our mission.


